Bridal Show Participation Agreement

Bridal Show @ Lions Park in Zionsville

THIS BRIDAL SHOW PARTICIPATION AGREEMENT, ("Agreement") made this _____ day of _____ 200__, between Ace Party rental and _____ ("EXHIBITOR").

WHEREAS, Ace Party Rental is holding the bridal show beginning at 11:00a.m. and ending at 4:00 p.m. on the date specified.

WHEREAS, EXHIBITOR desires to participate in the show subject to the covenants and conditions contained herein.

1. EXHIBITOR's participation is subject to all rules and regulations and show information sheets as promulgated by Ace Party Rental.
2. EXHIBITOR shall protect, indemnify and hold harmless Ace Party Rental from any and all claims, losses, costs, damages, or expenses of any kind or nature whatsoever, arising out of or from, any accident or occurrence in or at the EXHIBITOR's location, the consumption or existence at the Venue of any product sold by EXHIBITOR or its agents, the sale of goods by EXHIBITOR or its agents; or any act or omission of EXHIBITOR, its employees, servants, agents, or invitees.
3. EXHIBITORS shall: keep their booth space attended during the show, not permit any trash or garbage to accumulate, provide and/ or pay for any labor needed to set up and take down any display. EXHIBITOR shall leave the space occupied by them in the same condition as it was found.
4. EXHIBITOR shall not share or sublet its space or promote any other business at the show without the express written consent of Ace Party Rental.
5. Ace Party Rental shall provide booth space, which shall be assigned on a first-come, first-served basis. Space will include: A minimum 8'X 8' exhibits space; one clothed table, two chairs, and light refreshments.
6. Ace Party Rental is not responsible for the personal safety of the EXHIBITOR or its representatives from injury, or the safety of the property of the EXHIBITOR from theft or damage. EXHIBITOR waives all claims of every kind for damages based on personal property damage, destruction, loss or theft, personal injury or death, and or any other act or failure of Ace Party Rental.
7. The event will not be rescheduled due to weather, unless emergency situations beyond the control of Ace Party Rental arise. **The Zionsville Town Hall Community Room is our backup location due to unfavorable weather conditions.**
8. EXHIBITOR agrees that Ace Party Rental may list the EXHIBITOR in show promotional materials and use photography, video and/or other media taken at the show for publicity purposes without compensation to EXHIBITOR.
9. Shall litigation be necessary for Ace Party Rental to enforce any condition of this agreement, Ace Party Rental, in addition to any damages or relief awarded, shall be entitled to receive interest at the rate of one percent per month from the date of the breach, court costs, and reasonable legal and attorneys fees. Exhibitor agrees that jurisdiction, venue, and choice of law shall be in Marion County, Indiana.
10. No provision of this Agreement shall be modified except by the written mutual consent of both parties.
11. If any clause of this Agreement is found to be invalid or unenforceable, the remained of the Agreement shall continue in full force and effect without regard to any invalid clause.
12. Returned check fee \$50.00, all payments are non-refundable.
